

# Application for Free Enterprise Society Verified Identification Card

(Free Enterprise Society 6083 N. Figarden Drive PMB 208, Fresno, California 93722 (209) 966-7040.)

Recognition of the Free Enterprise Society Identification Card as a satisfactory form of identification arises from the case of *People v. Monroe* (1993) 12 Cal. App. 4<sup>th</sup> 1174, 1183-1194, consistent with California Legislation. According to the Court “*The form of identification must bear a **photograph and description of the person, their signature and a current mailing address, and must be current and serially or otherwise numbered. Such documentary evidence is the functional equivalent of a driver’s license because it is of equivalent reliability, and because it bears the information necessary to the citation process.***” A peace officer “*When presented with such proof **must** accept it as “satisfactory” [evidence of Identification.]*” 12 Cal. App 4<sup>th</sup> @ 1187. This identification card is also sanctioned under *Article IV Section 1* of the *United States Constitution – (Full Faith and Credit Clause)*, and *Article 1 of the Bill of Rights*.

This application is being presented to you because you have expressed a desire to obtain a professional Identification Card issued within the acceptable parameters our Courts, Legislature, and Constitution has established. This card is required to be accepted as satisfactory evidence of your identity by any state official or peace officer within the 50 United States of America and within any territory or possession of the United States government.

The information requested in the application is necessary so Free Enterprise Society can issue an identification card to the member requesting the card with the assurance that the member requesting the card is the individual who will be identified on the card. This application will remain on file with the Society in the event that a government official or peace officer feels compelled to verify the information on your identification card as being accurate and correct. However, in order to provide such verification we must have information in our office which satisfactorily establishes the truth of the information you submit on your application regarding your true identity.

Failure to provide the information requested could result in our inability to verify your identity should a inquiry be forthcoming in the future. Additionally, we reserve the right to reject your application in the event the information contained therein is unacceptable or is shown to be false. If we reject your application we will not issue an identification card unless and until an application is received from you which has information contained thereon which is acceptable to us. For each application submitted an additional fee is assessed. It is not our intent to invade your privacy. Rather, it is our desire to provide you with a reliable and professional service which is designed to provide you with an alternative to a government issued identification card.

The information contained in this application will be used for the exclusive purpose of verifying the accuracy of your identity should a person or entity to whom you present your identification card desire such verification. The submission of this application to Free Enterprise Society is your authorization to us to release the information herein disclosed to the person or entity desiring verification of your identity upon your presentation of your card to said person or entity.

The Free Enterprise Society Identification Card is valid for 3 years from the date of issue. Upon expiration of the identification card it is the responsibility of the member to renew the identification card by filling out a new application and supplying the necessary information for purposes of renewal. Failure to renew the card will result in Free Enterprise Society’s inability to verify the accuracy and veracity of the card and the information thereon if called upon to do so.

In the event your card is lost or stolen please notify Free Enterprise Society immediately. Members will be charged an additional fee in the event Free Enterprise Society reissues a lost or stolen card. All fees incurred by the member in connection with the submission of this application for the Free Enterprise Society Identification Card are non-refundable.

7. **Evidence of Identity.** (If you have this application notarized you may disregard this section.) Please attach two of any of the following documents. A copy of a state issued driver's license or identification card; a copy of your utility bill; an affidavit signed by two people, under penalty of perjury verifying your identity; a certified copy of your birth certificate, or copy of Passport. *Your application cannot be processed if this application is not notarized, or if two of the above documents are not enclosed with your application.*

8. **Photographs.** Include two current color photographs of yourself, size 1 1/4" width by 1 1/2" height. The photograph must clearly show your features.

9. **Renewal or Lost/Stolen Identification Card.** If this is a renewal or a request for a replacement of a lost/stolen identification card you may ignore items 2 through 5 above, unless there has been a change which would affect our ability to verify your identification card, i.e., change of address, telephone number, etc.

10. **Fees.** The fee for an original application is 75.00 and renewal is \$50.00. The fee for replacement of lost/stolen identification card is \$25.00. These fees are *nonrefundable*. Please enclose either blank postal money order or cash. If you enclose a check make checks payable to O.B.S. If you use postal money orders please leave them blank.
